The Minnesota Organization of Leader's in Nursing's (MOLN's) **2026 Spring Leadership Conference** is scheduled for **April 30 – May 1, 2026** at the Minneapolis Marriott Northwest, 7025 Northland Drive North, Minneapolis, Minnesota and we would love for you to participate as an exhibitor at the conference. Participating in the Spring Conference will provide you with an excellent opportunity to network with around 250 Nurse Executives in diverse leadership roles – and we hope you will choose to join us!

Exhibit hours are scheduled from 7:00 am – 3:30 pm on Thursday, April 30. Attendees will have scheduled times to visit exhibits throughout the day, including during breakfast, two 45-minute breaks and the luncheon.

Electricity is also available for an additional cost.
